### **MANAGEMENT SUMMARY**

At Lannett in FY2020, we focused on three undertakings at each of our facilities to highlight, improve and maintain our corporate sustainability measures: consistently implementing projects that reduce the total amount of energy & natural resources utilized, diverting waste materials from landfill disposal to material reuse or reclamation, and improving manufacturing operations to improve production output per unit of resources to reduce our effect on climate. This corporate environmental performance report highlights the progress made to increase, implement and improve our sustainability efforts in this fiscal year\*.

#### **RESPONSIBLE WATER USE**



FY2020 continued a downward trend of water use, as there was 1.1% less water used per batch across the company compared to FY2019. Additionally, Lannett used 10.5% less water per batch in FY2020 compared to FY2018.

#### **EFFICIENT USE OF ENERGY**



There was a 0.3% decrease of energy usage per batch in FY2020 compared to FY2019. This continues the decrease of corporate energy usage for Lannett as the FY2020 amount is 10% lower than the usage total in FY2018.

#### **CLIMATE ACTIVITY**



Lannett has decreased its amount of greenhouse gases emitted per batch by 5.8% in FY2020 compared to FY2019. Furthermore, the company has decreased its amount emitted per batch by 16.3% since FY2018 when the amount emitted was 1,866 metric tons of  $CO_2e$  per 100 batches.


#### WASTE MANAGEMENT



Waste generated per batch increased by 17.2% in FY2020 compared to FY2019. Also, the amount generated in FY2020 was 36% higher than the amount compared to FY2018. This was affected by increased production at our facilities and a record-number of products introduced into our portfolio.



### **ENERGY EFFICIENCY**


